General Insurance Code of Practice

Strata Managers first Concern Under the Strata Reform



Strata managers should now be aware that the General Insurance Code of Practice commenced on 1 July 2014. Insurers had 12 months to transition to the code, that was, until 30 June 2015. Those needing further information can go here.

Australian Consumer Law Reforms

Consumer Affairs Australia and New Zealand is currently seeking views on how the Australian Consumer Law (ACL) is working in practice and how it can be improved.

The <u>Issues Paper</u> released on 31 March 2016, kicks off the Australian Consumer Law Review and is available for an eight-week consultation period.

Swimming pool registers: reminder



From Friday 29 April 2016, vendors of a property with a swimming or spa pool must have a certificate showing whether or not their pool fencing is compliant with the *Swimming Pools Act* 1992.

Remember this is about Pool Safety.

The recent amendments relate to the conveyancing and leasing practice, they are not amendments to the obligation to have a pool compliance certificate. Owners corporations still needing advice can click <u>here</u>.

Strata Works Agreement and User Guide

Members of the Strata Services Committee have undertaken a full and comprehensive review of the Strata Works Agreement. The new document, which is also an interactive form, is now ready for Corporate Strata Services members who are financial to use.

This agreement was created to make works undertaken by strata service providers and owners corporations, subject to formal, legal agreements which clearly state the terms and conditions owners and contractors must operate within.

A User Guide is also available which members should carefully read before using the Agreement.

Each heritage listed property includes a Conservation Management Plan (CMP) endorsed by the NSW Heritage Council in the contract for sale.

These contracts ensure new property owners are fully informed of their responsibilities when purchasing a heritage listed property.

To date, 70 properties have been sold in Millers Point, totalling \$182.73 million, with the proceeds being reinvested into 1,500 new social housing dwellings across NSW.

NSW Government Backs UberX of Property Industry



From July, real estate agents in NSW will be required to keep a log of any building and pest, strata or contract review reports that have been done for any properties they have marketed.

This has allowed the NSW government to get behind the emerging trend of the sharing economy to allow costly inspection reports to be auctioned on to potential property buyers, saving them hundreds of dollars.


