New Strata Regulations have landed



As our President Greg Haywood advised in his communique last week, the NSW Government has released consultation drafts of the Strata Schemes Management Regulation 2016 and Strata Schemes Development Regulation 2016, with their accompanying Regulatory Impact Statements (RIS) all of which are available on our <u>website</u>.

In a media release the Government highlighted some of the details contained in the regulations such as:

provisions to accommodate modern technology for virtual meetings and electronic voting;
the documentation and procedures for the collective sale and renewal reform that enables a minimum of 75% of owners in a scheme to jointly agree to sell or redevelop their scheme; and
draft model by-laws on issues such as pet ownership and smoke penetration.

We have until Friday 27 May 2016 to make a submission to the Government outlining any changes

Strata Data is Back!



Members have approached us requesting the strata data that we used to provide in Inside Strata. We will be setting up a page on the SCA (NSW) website with quarterly updates.

As at February 2015 there were 769,832 lots registered in NSW. As at April 2016 there were 794,004 lots registered in NSW.
