According to the latest Land and Property Information (LPI) statistics there were **824,027 lots** registered in NSW as at 23 March 2017. This is an increase over six months since November 2016 of 8,518 lots in NSW when LPI recorded 815,509 lots registered.

NSW Fair Trading Survey: Strata Managers Wanted

Many agency agreements are due to expire on 29 May 2017 due to the operation of Section 50(1) and clause 14(1) of Schedule 3 of the Strata Schemes Management Act 2015.

For affected schemes, the managers were to notify the owners corporation on or before 28 February 2017 that their agreements were due to expire on 29 May 2017.
